The loss rate is less than 5% within the expiration date under appropriate storage condition.

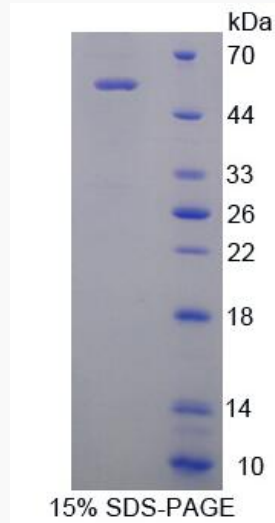
