## SPECIFICATION

<b>Product Overview</b>	FITC conjugated recombinant human CEACAM5 mature form (NP_004354.2) (Met 1-Ala 685), fused with the polyhistidine-tagged Fc region of human IgG1 at the C-terminus, was produced in Human Cell.

<b>Molecular Mass</b>	The recombinant human CEACAM5/Fc is a disulfide-linked homodimer after removal of the signal peptide. The reduced monomer consists of 899 amino acids and has a predicted molecular mass of 99.4 kDa. In SDS-PAGE under reducing conditions, the apparent molecular mass of rhCEACAM5/Fc monomer is approximately 160-180 kDa due to glycosylation.
<b>Endotoxin</b>	< 1.0 EU/ µg of the protein as determined by the LAL method.
<b>Characteristic</b>	Disulfide-linked homodimer Labeled with FITC via amines Excitation source: 488 nm spectral line, argon-ion laser Excitation Wavelength: 488 nm

<b>Stability</b>	Samples are stable for up to 12 months from date of receipt at -70 centigrade.
<b>Storage</b>	Store it under sterile conditions at -20 to -70 centigrade. It is recommended that the protein be aliquoted for optimal storage. Avoid repeated freeze-thaw cycles.
<b>Storage Buffer</b>	Lyophilized from sterile PBS, pH 7.4
<b>Reconstitution</b>	It is recommended that sterile water be added to the vial to prepare a stock solution. Centrifuge the vial at 4 centigrade before opening to recover the entire contents.
<b>Conjugation</b>	FITC
