<b>Product Overview</b>	Recombinant Human CNRIP1 protein(1-164 aa), fused with N-terminal GST tag, was expressed in E.coli.

<b>Form</b>	The purified protein was lyophilized from sterile phosphate-buffered saline (PBS: 58 mM Na <sub>2</sub> HPO <sub>4</sub> , 17 mM NaH <sub>2</sub> PO <sub>4</sub> , 68 mM NaCl, pH 8.0). Prior to lyophilization, 5% (w/v) trehalose and 5% (w/v) mannitol were incorporated as cryoprotective excipients. The protein was eluted with a buffer containing 100 mM reduced glutathione (GSH).

<b>Purity</b>	85%, by SDS-PAGE with Coomassie Brilliant Blue staining.
<b>Storage</b>	Store at 2-8°C for 1-2 weeks. Aliquot and store at -20°C to -80°C for up to 12 months, reconstitution with sterile water and addition of an equal volume of glycerol. Avoid repeat freeze-thaw cycles.

**Reconstitution**

Dissolve the product in 200 µl sterile water to achieve a working concentration of 0.25 g/µl. If experimental compatibility allows, mix the aqueous solution with an equal volume of glycerol (1:1 ratio) after initial reconstitution.
