<b>Stability</b>	Samples are stable for up to 12 months from date of receipt at -70 centigrade.
<b>Storage</b>	Store it under sterile conditions at -20 to -80 centigrade. It is recommended that the protein be aliquoted for optimal storage. Avoid repeated freeze-thaw cycles.
<b>Storage Buffer</b>	Lyophilized from sterile PBS, pH 7.4. Normally 5%-8% trehalose, mannitol and 0.01% Tween 80 are added as protectants before lyophilization.
<b>Shipping</b>	<p>Shipped at ambient temperature.</p> <p>Bulk packages of recombinant proteins are provided as frozen liquid. They are shipped out with blue ice unless customers require otherwise.</p>
