<b>Product Overview</b>	Recombinant Mouse Cd274 Protein extracellular domain (NP_068693.1, 1-238aa), was expressed in Human Cell with C-terminal His-tagged human IgG1 Fc tag and Alexa Fluor 647 conjugate.

<b>Molecular Mass</b>	The recombinant mouse PD-L1/Fc is a disulfide-linked homodimeric protein after proteolytic removal of the signal peptide. The reduced monomer consists of 468 amino acids and predicts a molecular mass of 52.8 kDa. As a result of glycosylation, the apparent molecular mass of rm PD-L1/Fc monomer is approximately 65-75 kDa in SDS-PAGE under reducing conditions.
<b>Endotoxin</b>	< 1.0 EU/ µg of the protein as determined by the LAL method.
<b>Characteristic</b>	Disulfide-linked homodimer Labeled with Alexa Fluor 647 via amines Excitation = 650 nm Emission = 668 nm

<b>Stability</b>	Samples are stable for up to 12 months from date of receipt at -70 centigrade.
<b>Storage</b>	Store it under sterile conditions at -20 to -70 centigrade. It is recommended that the protein be aliquoted for optimal storage. Avoid repeated freeze-thaw cycles.
<b>Storage Buffer</b>	Lyophilized from sterile PBS, pH 7.4
<b>Reconstitution</b>	It is recommended that sterile water be added to the vial to prepare a stock solution. Centrifuge the vial at 4 centigrade before opening to recover the entire contents.
<b>Conjugation</b>	Alexa Fluor 647
