### SPECIFICATION

<b>Product Overview</b>	Biotinylated Recombinant Human FGFR3 protein(P22607)(Asp127-Gly377), fused with C-terminal His and Avi tag, was expressed in HEK293.

<b>Conjugation/Label</b>	Biotin
<b>Form</b>	Lyophilized from 0.22µm filtered solution in PBS (pH 7.4). Normally 5% trehalose is added as protectant before lyophilization.
<b>Bio-activity</b>	Immobilized Biotinylated Human FGFR3 beta (IIIc), His Tag at 0.5ug/ml(100ul/well) on the streptavidin precoated plate (5ug/ml). Dose response curve for Anti-FGFR3 Antibody, hFc Tag with the EC50 of 4.1ng/ml determined by ELISA.
<b>Molecular Mass</b>	The protein has a predicted MW of 30.1 kDa. Due to glycosylation, the protein migrates to 50-60 kDa based on Tris-Bis PAGE result.
<b>Endotoxin</b>	Less than 1EU per µg by the LAL method.

<b>Purity</b>	> 95% as determined by Tris-Bis PAGE;> 95% as determined by HPLC
<b>Storage</b>	Reconstituted protein stable at -80°C for 12 months, 4°C for 1 week. Use a manual defrost freezer and avoid repeated freeze-thaw cycles.
<b>Reconstitution</b>	Centrifuge tubes before opening. Reconstituting to a concentration more than 100 µg/ml is recommended. Dissolve the lyophilized protein in distilled water.
<b>Conjugation</b>	Biotin

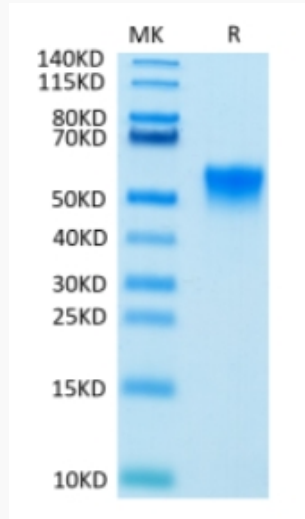

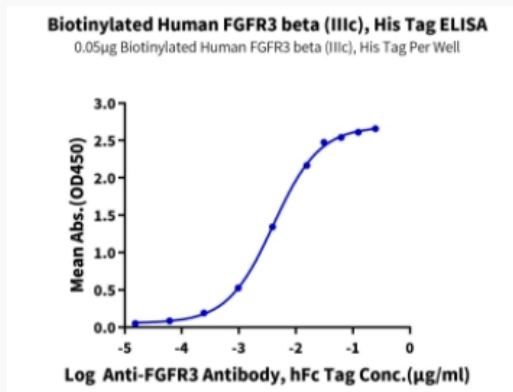
