<b>Form</b>	The purified protein was Lyophilized from sterile PBS (58mM Na <sub>2</sub> HPO <sub>4</sub> , 17mM NaH <sub>2</sub> PO <sub>4</sub> , 68mM NaCl, pH8.). 5 % trehalose and 5 % mannitol are added as protectant before lyophilization. The elution buffer contain 100mM GSH.

**Reconstitution**

Reconstitute at 0.25 g/μl in 200 μl sterile water for short-term storage.  
 Reconstitution with 200 μl 50% glycerol solution is recommended for longer term storage.
