<b>Form</b>	Lyophilized from sterile 20 mM Tris, 500 mM NaCl, pH 7.4, 10 % glycerol. Please contact us for any concerns or special requirements. Normally 5 % - 8 % trehalose, mannitol and 0.01% Tween80 are added as protectants before lyophilization. Please refer to the specific buffer information in the hard copy of CoA.
<b>Bio-activity</b>	1. Measured by its ability to bind with Neu5Aca2-3Galb1-4GlcNAcb-PAA-biotin (01-07 7) using the Octet RED System. 2. Measured by its ability to agglutinate guinea pig red blood cells. HA titer is 0.1-1µg/mL for 1% GRBC.
<b>Molecular Mass</b>	The recombinant hemagglutinin of Influenza A virus (A/chicken/Italy/22A/1998(H5N9)) comprises 522 amino acids and has a predicted molecular mass of 59.3 kDa. The apparent molecular mass of the protein is approximately 60.1 kDa in SDS-PAGE under reducing conditions.

<b>Endotoxin</b>	< 1.0 EU per µg of the protein as determined by the LAL method
<b>Purity</b>	> 95 % as determined by SDS-PAGE
<b>Storage</b>	Samples are stable for up to twelve months from date of receipt at -20°C to -80°C Store it under sterile conditions at -20°C to -80°C. It is recommended that the protein be aliquoted for optimal storage. Avoid repeated freeze-thaw cycles.
<b>Reconstitution</b>	It is recommended that sterile water be added to the vial to prepare a stock solution of 0.2 ug/ul. Centrifuge the vial at 4°C before opening to recover the entire contents.
