### SPECIFICATION

<b>Product Overview</b>	Recombinant SARS-CoV-2 (2019-nCoV) Spike RBD (YP_009724390.1, with mutations K417N, E484K, N501Y) (Arg319-Phe541) was expressed in HEK293 cell with a polyhistidine tag at the C-terminus. The purified protein was biotinylated in vitro. The mutations were identified in the SARS-CoV-2 variant (known as 20C/501Y.V2 or B.1.351 lineage) which emerged in South Africa.

<b>Molecular Mass</b>	The recombinant SARS-CoV-2 (2019-nCoV) Spike RBD consists of 235 amino acids and predicts a molecular mass of 26.7 kDa. As a result of glycosylation, it migrates as an approximately 36 kDa band in SDS-PAGE under reducing conditions.
<b>Endotoxin</b>	< 1.0 EU/μg protein as determined by the LAL method.
<b>Purity</b>	> 95 % as determined by SDS-PAGE.
<b>Storage</b>	Samples are stable for up to twelve months from date of receipt at -20 to -80 centigrade.
