<b>Product Overview</b>	Recombinant COVID-19 Spike S1(T20N, D614G)-His Recombinant Protein (YP_009724390.1) (Met1-Arg685(T20N, D614G)) was expressed in HEK293 with a polyhistidine tag at the C-terminus.

<b>Source</b>	HEK293
<b>ProteinLength</b>	Met1-Arg685
<b>Form</b>	Lyophilized from sterile PBS, pH 7.4. Normally 5 % - 8 % trehalose, mannitol and 0.01% Tween80 are added as protectants before lyophilization.
<b>Molecular Mass</b>	The recombinant SARS-CoV-2 (2019-nCoV) Spike S1(T20N, D614G)-His Recombinant Protein consists of 681 amino acids and predicts a molecular mass of 76.4 kDa. As a result of glycosylation, it migrates as an approximately 113.5 kDa band in SDS-PAGE under reducing conditions.
<b>Endotoxin</b>	< 1.0 EU per µg protein as determined by the LAL method.
<b>Purity</b>	> 90 % as determined by SDS-PAGE.
<b>Storage</b>	Samples are stable for up to twelve months from date of receipt at -20°C to -80°C. Store it under sterile conditions at -20°C to -80°C. It is recommended that the protein

be aliquoted for optimal storage. Avoid repeated freeze-thaw cycles.

**Reconstitution**

It is recommended that sterile water be added to the vial to prepare a stock solution of 0.2 ug/ul. Centrifuge the vial at 4°C before opening to recover the entire contents.
