<b>Product Overview</b>	Alexa Fluor 647 conjugated recombinant Mouse Tnfrsf10b (NP_064671.2) extracellular domain (Met 1-Ser 177), fused with the polyhistidine-tagged Fc region of human IgG1 at the C-terminus, was produced in Human Cell.

<b>Molecular Mass</b>	The recombinant mouse TNFRSF10B/Fc chimera is a disulfide-linked homodimer. The reduced monomer consists of 373 amino acids and has a calculated molecular mass of 41.8 kDa. As a result of glycosylation, the apparent molecular mass of the TNFRSF10B/Fc monomer is approximately 50-55 kDa in SDS-PAGE under reducing conditions.
<b>Endotoxin</b>	< 1.0 EU/ µg of the protein as determined by the LAL method.
<b>Characteristic</b>	Disulfide-linked homodimer Labeled with Alexa Fluor 647 via amines Excitation = 650 nm Emission = 668 nm

<b>Stability</b>	Samples are stable for up to 12 months from date of receipt at -70 centigrade.
<b>Storage</b>	Store it under sterile conditions at -20 to -70 centigrade. It is recommended that the protein be aliquoted for optimal storage. Avoid repeated freeze-thaw cycles.
<b>Storage Buffer</b>	Lyophilized from sterile PBS, pH 7.4
<b>Reconstitution</b>	It is recommended that sterile water be added to the vial to prepare a stock solution. Centrifuge the vial at 4 centigrade before opening to recover the entire contents.
<b>Conjugation</b>	Alexa Fluor 647
