

Active Recombinant Human CD22 Protein, LIgG2b Fc-tagged, low endotoxin

SPECIFICATION

Product Overview	Recombinant Human CD22 Protein, LIgG2b Fc-tagged, low endotoxin is expressed from human 293 cells (HEK293). It contains AA Asp 20 - Arg 687 (Accession # P20273-1). Predicted N-terminus: Asp 20. This protein carries a llama IgG2b Fc tag at the C-terminus. The protein has a calculated MW of 103.0 kDa. The protein migrates as 120-140 kDa under reducing (R) condition (SDS-PAGE) due to glycosylation.

Form	Lyophilized from 0.22 µm filtered solution in 50 mM Tris, 100 mM Glycine, pH7.5. Normally trehalose is added as protectant before lyophilization.
Bio-activity	Immobilized Recombinant Human CD22 Protein, LIgG2b Fc-tagged, low endotoxin at 2 µg/mL (100 µL/well) can bind Anti-Human CD22 with a linear range of 4-63 ng/mL (QC tested).
Molecular Mass	103.0 kDa
Endotoxin	Less than 0.01 EU per µg by the LAL method.

Purity	>95% as determined by SDS-PAGE.
Notes	Please avoid repeated freeze-thaw cycles.
Stability	No activity loss is observed after storage at: 4-8 centigrade for 12 months in lyophilized state; -70 centigrade for 3 months under sterile conditions after reconstitution.
Storage	For long term storage, the product should be stored at lyophilized state at -20 centigrade or lower.
Reconstitution	It is recommended that sterile water be added to the vial to prepare a stock solution of 0.2 mg/ml. Centrifuge the vial at 4 centigrade before opening to recover the entire contents.

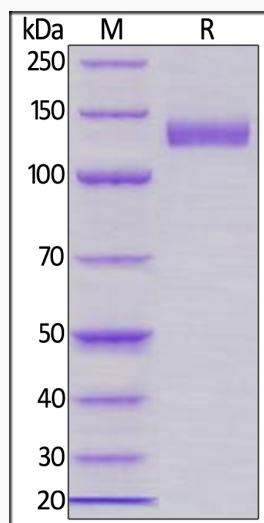
