Form	Lyophilized from 0.22 µm filtered solution in PBS, pH7.4 . Normally trehalose is added as protectant before lyophilization.
Bio-activity	Immobilized Human ACE2, Fc Tag at 5 µg/mL (100 µL/well) can bind SARS-CoV-2 Spike RBD, His Tag (BA.4&BA.5/Omicron) with a linear range of 16-125 ng/mL.
Molecular Mass	The protein has a calculated MW of 26.7 kDa. The protein migrates as 33-36 kDa under reducing (R) condition (SDS-PAGE) due to glycosylation.
Endotoxin	Less than 1.0 EU per µg by the LAL method.
Purity	>95% as determined by SDS-PAGE. >90% as determined by SEC-MALS.

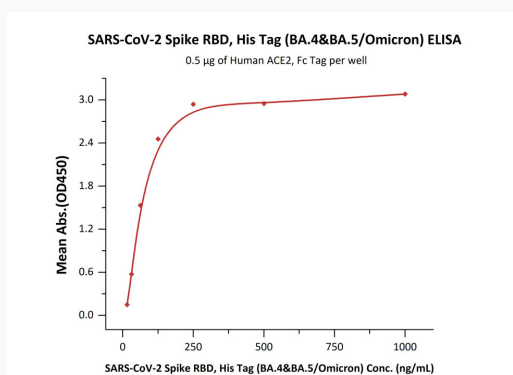

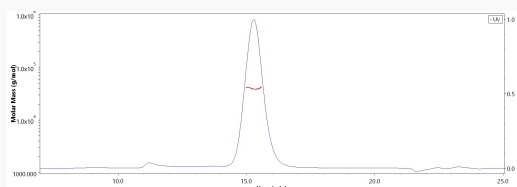

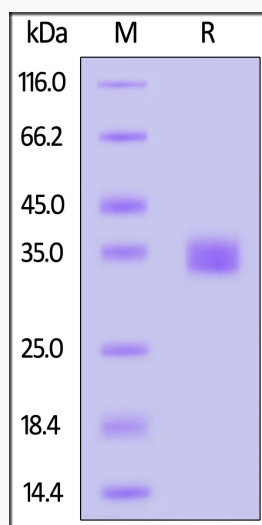
