Form	Lyophilized from 0.22 µm filtered solution in 50 mM Tris, 100 mM Glycine, 0.2 M Arginine, 150 mM NaCl, pH7.5. Normally trehalose is added as protectant before lyophilization.
Bio-activity	Immobilized Human ACE2, His Tag at 2 µg/mL (100 µL/well) can bind SARS-CoV-2 S1 protein, Fc Tag with a linear range of 0.4-6 ng/mL. Immobilized SARS-CoV-2 S1 protein, Fc Tag at 2 µg/mL (100 µL/well) can bind Human ACE2, His Tag with a linear range of 0.078-0.156 µg/mL.
Molecular Mass	This protein carries a human IgG1 Fc tag at the C-terminus. The protein has a calculated MW of 101.1 kDa. The protein migrates as 125-150 kDa under reducing (R) condition (SDS-PAGE) due to glycosylation.
Endotoxin	Less than 1.0 EU per µg by the LAL method.

Purity	>95% as determined by SDS-PAGE.
Storage	For long term, the product should be stored at lyophilized state at -20°C or lower. Please avoid repeated freeze-thaw cycles. This product is stable after at: -20°C to -70°C for 12 months in lyophilized state; -70°C for 3 months under sterile conditions after reconstitution.
Reconstitution	It is recommended that sterile water be added to the vial to prepare a stock solution of 0.2 ug/ul. Centrifuge the vial at 4°C before opening to recover the entire contents.
