SPECIFICATION

Product Overview	Recombinant SARS-CoV-2 Spike RBD (YP_009724390.1, with mutation R346S, N394S, Y449N, F490R, N501Y) (Arg319-Phe541) was expressed in HEK293 with a polyhistidine tag at the C-terminus. The mutations were identified in the SARS-CoV-2 variant (known as variant B.1.640).

ProteinLength	Arg319-Phe541
Form	Lyophilized from sterile PBS, pH 7.4. Normally 5 % - 8 % trehalose, mannitol and 0.01% Tween80 are added as protectants before lyophilization.
Bio-activity	Immobilized ACE2 Protein, Human, Recombinant (mFc Tag) at 2 µg/mL (100 µL/well) can bind SARS-CoV-2 (B.1.640) Spike RBD Protein (His Tag), the EC50 is 8-24ng/mL.
Molecular Mass	The recombinant SARS-CoV-2 Spike RBD consists of 234 amino acids and predicts a molecular mass of 26.46 kDa. As a result of glycosylation, it migrates as an approximately 32.88 kDa band in SDS-PAGE under reducing conditions.
Endotoxin	< 1.0 EU per µg protein as determined by the LAL method.

Purity	> 95 % as determined by SDS-PAGE. > 95 % as determined by SEC-HPLC.
Storage	Samples are stable for up to twelve months from date of receipt at -20°C to -80°C. Store it under sterile conditions at -20°C to -80°C. It is recommended that the protein be aliquoted for optimal storage. Avoid repeated freeze-thaw cycles.
Reconstitution	It is recommended that sterile water be added to the vial to prepare a stock solution of 0.2 ug/ul. Centrifuge the vial at 4°C before opening to recover the entire contents.
