Substance: recombinant protein was purified from Nicotiana Benthamiana.
Formulation: Recombinant human IL-6 is lyophilized from 10mM Phosphate Potassium buffer pH 7.4 and 50mM NaCl.

4. First Aid Measures

- (1) Inhalation: If inhaled, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical attention.
- (2) Ingestion: Do NOT induce vomiting unless directed to do so by medical personnel. Never give anything by mouth to an Unconscious person. If large quantities of this material are swallowed, call a physician immediately. Loosentight clothing such as a collar, tie, belt or waistband.
