Substance: recombinant protein was purified from E.coli.
Formulation: Liquid. Supplied in 20mM Tris-HCl pH7.9, 20% glycerol, 100mM KCl, 0.2mM EDTA and 1mM DTT.

4. First Aid Measures

- (1) Inhalation: If inhaled, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical attention.
