3. Composition / Information on Ingredients

Substance: native protein was purified from Bovine.
Formulation: Sterile, clear dark purple solution. It contains 130 mg/ml polymerized hemoglobin of bovine origin in a modified Lactated Ringer's Solution containing Water for Injection 100 g/dL, NaCl 113 mmol/L, KCl 4 mmol/L, CaCl₂·2H₂O 1.4 mmol/L, NaOH 10 mmol/L, Sodium Lactate 27 mmol/L, N-acetyl-L-cysteine 200 mg/dL with a pH of 7.6 - 7.9. It contains ≤ 3.5 µg/mL free-glutaraldehyde.

4. First Aid Measures

- (1) Inhalation: If inhaled, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical attention.
- (2) Ingestion: Do NOT induce vomiting unless directed to do so by medical personnel. Never give anything by

mouth to an Unconscious person. If large quantities of this material are swallowed, call a physician immediately. Loosentight clothing such as a collar, tie, belt or waistband.

- (3) Skin contact: In case of contact, immediately flush skin with plenty of water. Remove contaminated clothing and shoes. Wash clothing before reuse. Thoroughly clean shoes before reuse. Get medical attention.
- (4) Eye contact: Check for and remove any contact lenses. In case of contact, immediately flush eyes with plenty of water for at least 15 minutes. Get medical attention.
- (5) Aggravating conditions : Repeated or prolonged exposure is not known to aggravated medical condition.
