Substance: recombinant protein was purified from Sf9 Cells.
Formulation: Recombinant protein in storage buffer (50 mMTris-HCl, pH 7.5, 150 mMNaCl, 0.25 mM DTT, 0.1 mMEGTA, 0.1 mM EDTA, 0.1 mM PMSF, 25% glycerol).

4. First Aid Measures

- (1) Inhalation: If inhaled, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical attention.
- (2) Ingestion: Do NOT induce vomiting unless directed to do so by medical personnel. Never give anything by
