Substance: native protein was purified from Human Plasma.
Formulation: The product is provided in a solution with 154 mM NaCl, 5.6 mM Na₂HPO₄, 1.1 mM KH₂PO₄, and 0.34 mM EDTA, at pH 7.4.

4. First Aid Measures

- (1) Inhalation: If inhaled, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical attention.
