3. Composition / Information on Ingredients

Substance: native protein was purified from Human Pancreas.
Formulation: Lyophilised:Reconstitute in 56.5µl 2mM HCl. Use product immediately after bringing to neutral pH to avoid auto-degradation.After reconstitution, aliquot and store at -20oC.Avoid multiple freeze/thaw cycles.

4. First Aid Measures

- (1) Inhalation: If inhaled, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical attention.
- (2) Ingestion: Do NOT induce vomiting unless directed to do so by medical personnel. Never give anything by mouth to an Unconscious person. If large quantities of this material are swallowed, call a physician

immediately. Loosentight clothing such as a collar, tie, belt or waistband.
